MODE SELECTION SWITCH




- 1 XBOX WHEEL MODE** - For Xbox use only - enables compatibility with games that natively support steering wheels. Can be used with wired and wireless connections.
- 2 PC AND XBOX CONTROLLER MODE** - Controller mode enables compatibility with games that do not normally support steering wheels on Xbox. Can be used with wired and wireless connections.
- 3 BLUETOOTH® MODE** - For Android Smart Devices such as mobile phones and smart TVs. Bluetooth wireless connection only.

AUDIO CONTROLS

Connect your 3.5mm headset for enhanced audio features. Not available in Bluetooth® mode. Chat mix is not compatible with Windows.


Press and hold the **Multi-Function Button (MFB)** to use onboard audio controls.

Tap the **MFB** to mute or unmute your mic. **MFB LED ON** = Mic Muted, **MFB LED OFF** = Mic Active.



BUTTON MAPPING

- 1 Press and hold **MFB**
- 2 Still holding **MFB**, press and hold the **F BUTTON** you would like to map a control to, until the status LED begins to blink once every second.
- 3 Press any existing controller button on Racer to map that control to your chosen **F BUTTON**.




New button mappings override existing ones. To delete a button mapping, press and hold **MFB** and then press and hold the **F BUTTON**. Tap the same **F BUTTON** again to delete the control mapping.


Search for Control Center 2 app on the Microsoft Store. Customize performance settings and keep your device up to date on Xbox and Windows.
